### COMMUNICATION FROM THE MAYOR

Mayor Burton stated that Mary Hatmaker volunteered to serve on the Anderson County Library Board to finish the term of Megan Thomas. Councilman Zach Ferrar made the motion to approve and second by Councilman Rob Herrell. Motion carried.

### **City School Board Report**

## **CITY MANAGER'S REPORT**

City Manager Houck stated that the City had advertised and received sealed bids for the purchase of new Self-Contained Breathing Apparatus (SCBA) and related accessories for the Fire Department. After evaluation of the bid, he request authorization to accept the bid for the SCBA units and related accessories from Safe Industries in the total amount of \$68,285.82 that will be funded from the Capital Projects Fund. Councilman Jim McBride made the motion to approve and second by Councilman E.T. Stamey. Motion approved unanimously by roll call vote.

City Manager Houck stated that the Glen Alpine extension agreement expired in February and asked City Council to give Anderson County an additional extension since the lawsuit will be heard next week in Chancery Court and County Commission took a second offer on a piece of property. He recommends at least 150 day extension. Councilman Jim McBride made a motion to extend the agreement until August 24<sup>th</sup> and seconded by Councilman E.T. Stamey. Motion carried.

City Manager Houck request a date for the budget workshop before the May meeting. City Council decided on May 5<sup>th</sup> at 5:00pm.

Finance Director Gail Cook discussed the financial report.


**ORDINANCES AND RESOLUTIONS**
