
Clinton Regional Planning Commission Report

Councilman Larry Gann reported that the board met on April 13, 2015 applicant Ronald Swanner request for final plat for property located on Greenwood Drive was approved.


Board of Zoning Appeals

Tim Thompson reported that the Economic Development Organizations in Oak Ridge and Roane County along with ACEDA met and discussed putting a resolution together to present to the State Legislature. He said that all the technology and innovation developing in our surrounding area, is attracting a lot of private companies so these organizations wanted to designate Exit 122 at I-75 to the Kingston Exit 140 as the Tennessee Innovation Corridor. He stated that Resolution #728 is basically a "Marketing Tool" and that the City would not be out any funding and that ACEDA would be responsible for road signs. Councilman E.T. Stamey made a motion to approve and second by Councilman Jim McBride. Motion carried.

Applicant Steve Clapp request for left side setback to 0 ft. for property located at 702 Riverbend Road was approved.

No recommended Budget Amendment in Cafeteria Fund at this time.

CAFETERIA FUND:

- Increase in Medical and Dental Insurance funded by various line items
 - Increase in medical & dental insurance due to staffing changes

The recommended Budget Amendment in Federal Projects Fund increases appropriations by \$9,012. The increase is funded by a decrease in appropriations of \$9,012.

FEDERAL PROJECTS FUND:

- Increase in Building Improvements funded by decrease in Salaries
 - Buzzer door installations at SCS
 - Insulated ceiling installation at CCS Technology and Food Service offices
- Increase in Audit Services funded by decrease in Salaries
 - Recognize possible 2014-2015 year end preliminary audit services
- Increase in Staff Development funded by UTRUST Grant
 - 14-15 Support Staff annual banquet

The recommended Budget Amendment in General Purpose School Fund increases appropriations by \$9,800. The increase in appropriations is funded by a decrease in appropriations of \$9,000 and an increase in revenues of \$800.
